# WEDDING CONTRACT

**BOOKINGS:** TO SECURE A DATE, A SIGNED CONTRACT IS REQUIRED WITH A \$100 NON-REFUNDABLE DEPOSIT AT THE TIME OF SIGNING. PLEASE BE ADVISED THAT A DATE AND THE SERVICES OF SALON ON THE HUDSON'S ARTISTIC TEAM WILL ONLY BE RESERVED ONCE A SIGNED CONTRACT AND DEPOSIT ARE RECEIVED. THE DEPOSIT WILL BE DEDUCTED FROM THE WEDDING DAY BALANCE.

**TRAVEL FEES:** A FLAT FEE OF \$100 WILL BE CHARGED FOR ANY SERVICES BEING PERFORMED ON LOCATION OR ANYWHERE OUTSIDE OF SALON ON THE HUDSON WITHIN A 50-MILE RADIUS. TRAVEL FEES EXCEEDING A 50-MILE RADIUS WILL BE DETERMINED ON A CASE-BY-CASE BASIS.

**FINAL HEADCOUNT:** A FINAL HEADCOUNT FOR SERVICES RENDERED WILL BE DUE IN WRITING 30 DAYS PRIOR TO THE EVENT. NO ADJUSTMENTS MAY BE MADE AFTER THE FINAL HEADCOUNT FOR GUESTS WHO MAY CHANGE THEIR MIND OR MISS THEIR APPOINTMENT.

**CANCELLATION POLICY:** IN THE UNFORTUNATE EVENT THAT SALON ON THE HUDSON'S SERVICES MUST BE CANCELLED, YOUR DEPOSIT WILL NOT BE REFUNDED. CANCELLATIONS THAT ARE RECEIVED 0-14 DAYS PRIOR TO THE EVENT WILL RESULT IN 50% OF ALL PLANNED SERVICES CHARGED TO THE PARTY THAT HAS SIGNED THIS CONTRACT.

**PAYMENT INFORMATION:** AS A PART OF OUR WEDDING AGREEMENT, SALON ON THE HUDSON REQUIRES A CREDIT CARD TO RESERVE YOUR WEDDING DATE AS WELL AS ANY TRIAL APPOINTMENTS.
